
**Sub: Inclusion of 7 to 10% of IPDS Outlay in State level sanctions of rooftop Solar PV systems under IPDS projects-reg.**

The IPDS guidelines approved by the Monitoring committee envisages to cover works relating to strengthening of sub-transmission & distribution network in urban areas, IT enabling, metering of Feeders, Distribution transformers and consumers including provisioning of solar panels on Govt. buildings including Net-metering. As per the directions of M.O.P. letter No. 26/8/2015-IPDS dated 24<sup>th</sup> August and 14<sup>th</sup> Sept. 2015, you are advised to ensure that 7 to 10% of IPDS outlay is sanctioned for Rooftop solar systems.


