The Ministry of Power, GoI has accorded In-principle approval to the IPDS and DDUGJY schemes in TSSPDCL for an amount of Rs. 450.20 Crs. and Rs. 336.66 Crs. respectively.

The proposal received from you vide reference 3rd cited for appointing as common Project Management Agency for execution of IPDS and DDUGJY schemes in TSSPDCL on nomination basis is accepted after conducting negotiation with you on 11.02.2016 subject to the following conditions.

- Consultancy fee will be @1% of total approved cost of DPRs under IPDS & DDUGJY scheme plus service tax, with contract period of 31 months.
- Terms and conditions of PMA Agreement will be in line with the PMA agreement concluded by APSPDCL with M/s.REC PDCL
- The start date of contract will be the date of Agreement between TSSPDCL & REC PDCL
- The agreement will be concluded after getting financial approval of IPDS & DDUGJY schemes from MOP, GOI (Only In-Principle sanction is obtained so far.)

- 10% of estimated consultancy fee will be paid to M/s.REC PDCL only after entering into agreement .
- Being a wholly subsidiary of REC Ltd, M/s.REC PDCL will be exempted from payment of Performance security.

Hence, you are requested to furnish your acceptance to the above conditions within 7 days from the date issue of LOA.
